Grantee agrees that the Scotts Bluff Area Visitors Bureau will not be liable for any accident or injury which may result during construction or use of Grantees facility and expressly agrees to hold the Scotts Bluff County Tourism Bureau, any of its agents or assignees, harmless for any liability associated with Grantee's construction or use of its facilities.
